## 2024-2025 School Year Preschool Re-enrollment and TK/Kinder Enrollment



### Current School Year Ends Thursday, June 27, 2024

**Beginning and End of Year Dates:** FCS Preschool is a full year program; however, we do have a beginning of the year and an end of the year. Thursday, June 27 is the last day of the 2023-2024 year, and all children that are eligible to apply for Transitional Kindergarten and Kindergarten will age out on that day. Please note that our Preschool Promotion to celebrate these two groups will be on Friday, June 21 in the morning. We are closed for professional development on June 28, and on July 4 to observe Independence Day. Monday, July 1, is the first day of the **2024-2025** year for all returning preschool students.

**What is FCS Preschool Reenrollment?** In order to guarantee placement in the **2024-2025** preschool school year, which begins July 1, 2024, all currently enrolled families must complete reenrollment. You will receive an email from FCS in mid-February that will prompt you to complete the online re-enrollment through FACTS. Please do not delay. Re-enrollment is due March 1.

After FCS receives your reenrollment, your updated Admissions Agreement for **2024-2025**, and your child's March parent conference is complete, we will inform you of your child's placement for the **2024-2025** school year. Your child's new classroom placement begins on July 1. Classroom placement letters are sent out in the first week of June.

**How do I enroll in FCS Transitional Kindergarten?** FCS Transitional Kindergarten is specifically for children turning five between **September 2, 2024– June 2, 2025**. Eligible FCS preschool students have first priority for the limited spaces available. Students eligible for TK will receive a reenrollment notice in mid-March with a due date 5 business days from the date of the email. Please refer to the tuition and fees schedule to understand all fees that will be due at the time of reenrollment. Tuition and fees schedules will be available at [fremontchristian.com](http://fremontchristian.com) in February.

**How do I enroll in FCS Kindergarten?** Children who are five years old before **September 2, 2024** are eligible for FCS Kindergarten. Eligible FCS Preschool and TK students have first priority for the limited spaces available. Students eligible for Kindergarten will receive a reenrollment notice in mid-March with a due date 5 business days from the date of the email.

Please refer to the tuition and fees schedule to understand all fees that will be due at the time of reenrollment. Tuition and fees schedules will be available at [fremontchristian.com](http://fremontchristian.com) in February. *Please follow the prompts on the reenrollment email to ensure enrollment and/or to ensure guidance regarding conditional enrollment terms.*



**An Important Note Regarding Daily Sign In and Out**— Please remember that it is important for your child to arrive at school on time. Check in is between 8:00 and 9:00 AM, anything after 9:00 is considered late. A \$10 late fee will be charged for all unexcused tardies and excessive tardiness may lead to disciplinary action. Community Care Licensing requires a parent or designated guardian **ONLY** to sign your child in or out of school. Please do not allow your children to touch the sign in IPADS.
